

## PDL '2024 Club Schneider Survey' Promotion (January – February 2025) TERMS AND CONDITIONS

- 1. Information on how to enter PDL Club Schneider End of Year 2024 Survey and the prizes form part of these Terms and Conditions.
- 2. Any entry which does not comply with these Terms and Conditions is invalid.
- 3. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 4. Entry is only open to New Zealand residents aged 18 years or over who are a registered electrician in New Zealand and are a Club Schneider member.
- 5. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter.
